The unqualified right and permission to reproduce, copyright, publish, circulate, and otherwise use photographs and/or motion pictures of me and my animal, and voice and/or noise reproduction, whether taken in studio or elsewhere, in black and white or in color, alone or in conjunction with other persons or characters, in any part of the world, in accordance with the above purpose and intended use.

2. All of my rights, title and interest in and to all negatives, prints, tapes and reproduction thereof. I also release the FVMA and its successors and assigns if any, from any and all rights, claims, demands, actions or suits on account of the use of publication of said photographs and/or motion pictures or tapes.
